1. Call the meeting to order – Saifee
 - a. Noted there were 11 members in attendance, the meeting proceeded. (7 are required)
 - b. Introduced the newly elected board and thanked all who ran and voted.
2. Approval of the June 16, 2025, and August 18 General Meeting Minutes, and the September 15 Annual Meeting Minutes.
 - a. Motion to approve the previous meeting minutes raised by Saifee, second by John Combest, all ayes in favor.
3. Treasurer's Report – Melissa
 - a. 2024/25 Audit 2024/25
 - i. We ended last year with \$9,618 in the checking after all the uncashed checks are cashed and \$10,649 in the saving account for reserve funds set aside for the insurance deductible, possible future legal services and unforeseen parks expenses.
 - b. 2025/26 Forecast
 - i. About \$4,316 of the money in the checking account will be used to help cover this year's expenses forecasted to be \$23,316. The forecast is to end the year with \$5,302 in the checking account. There was \$2,500 added to the reserve fund for possible future legal services so \$13,149 is the forecast for the savings account.
 - c. 2025/26 Annual Dues Rate
 - i. Dues will remain unchanged at \$175!
 - d. The attending membership agreed to the budgeting forecast, annual dues to remain unchanged, and the \$2500.00 added to the legal fund.
 - e. Question was raised by Connie about potentially renting the parks out to the membership for parties and events. The agreement was struck that any event request will be made to the HOA President and no fee's will be incurred to the requesting member (must be in good standing). The responsibility of set up, take down and cleanup is the requested members.
4. Vice President's Report – Saifee
